Oaktech Pty Ltd T/A Eureka Garages & Sheds ABN 93 060 638 888 ('we', 'our' or 'us') understands that people are concerned about how their personal information that companies may collect and retain may be used. This privacy policy confirms our commitment to ensuring the privacy and security of any personal information that we hold in conducting our business in accordance with the Australian Privacy Principles established under the Privacy Act 1988.

### **WHAT KINDS OF PERSONAL INFORMATION DO WE COLLECT?**

The type of information we may collect, and hold includes personal information about:

- Customers, business associates, potential customers and their employees, contractors and agents;
- Information concerning individuals that we collect in the course of dealing with customers, business associates, potential customers and their employees, contractors and agents;
- Suppliers and their employees;
- Employees, prospective employees, contractors and agents; and
- Other people who come into contact with us.

In general, the personal information we collect, and hold includes a person's name, contact details, occupation, personal preferences, payment, banking and other financial details, employment history, education and qualifications, testimonials and feedback, and other information which assists us in conducting our business, providing and marketing our services and meeting our legal obligations.

In some cases, we may also collect 'sensitive information', such as information about an individual's membership of a professional association, criminal record or health information and credit ability information about you, such as credit reports, consumer credit liability information and payment history.

### **HOW DO WE COLLECT PERSONAL INFORMATION?**

We collect personal information in a number of ways, including (whether in person, in writing or online):

- When purchasing from us;
- When registering a product warranty;
- When submitting an enquiry or booking a service call;
- When responding to promotional offers or competitions;
- When conducting customer satisfaction and market research surveys;
- When completing applications, authorities and other forms;
- When accessing our website; and
- Via third parties, including credit reporting bodies and debt collection agencies.

## WHY YOUR INFORMATION IS COLLECTED AND HOW IT IS USED BY US

We collect personal information to conduct our business and to provide you with the specific goods and services you require and to administer services, such as those mentioned above, and to ensure that our service levels are always of the highest standard. We also use personal information:

- To send you information (by email or post) that you explicitly request. (Note: If at any time you receive material that you did not request or if you no longer want to receive such material, see 'How Can You 'Opt Out'? below);
- To promote and market to you details of our products and services which we consider may be of interest to you, including information about special offers and competitions;
- To comply with our legal obligations
- To conduct appropriate credit checks;
- To facilitate third parties to assist us in providing our goods and services (including hosting and data storage providers and debt collectors, whether located within or outside Australia); and
- For our internal marketing, research and analysis purposes to assist us in better understanding our market, our customers, their needs and their views about our products and services. For these purposes, we develop aggregate or summary (i.e. not individual) reports which incorporate some personal information. These reports do not include any personally identifiable information.

## COOKIES

A cookie is a data file that a website transfers to your computer. This enables the website to track the pages you have visited. A cookie only contains information you supply. It cannot read data on your computer. Our website uses cookies. You can set your browser to refuse cookies, however, this may mean you are unable to take full advantage of our website.

## WHO MAY WE DISCLOSE YOUR PERSONAL INFORMATION TO?

We may disclose your personal information (including, in certain limited circumstances, your sensitive information):

- To our related companies & businesses;
- To entities who assist us in providing our services (including hosting and data storage providers and credit reporting bodies and debt collection agencies);
- Where we are required to do so by law.

We will not sell, rent, trade or otherwise supply personal information to outside third parties without your consent except where:

- Such disclosure is permitted under the Privacy Act 1988;
- We are required or authorised by law to disclose information;
- We have outsourced service providers who manage the services we provide to you.

## **HOW DO WE MAINTAIN SECURITY OF YOUR PERSONAL INFORMATION?**

We take reasonable care to keep your personal information secure and confidential. We have security measures in place designed to protect against the loss, misuse and/or alteration of your personal information under our control. These security measures include restricting and securing access to our databases. We regard unauthorised use of or access to your personal information by our employees, contractors or agents as a serious matter that will be subject to appropriate disciplinary or other action.

## **HOW CAN YOU ACCESS, CORRECT AND UPDATE YOUR PERSONAL INFORMATION?**

Subject to the exceptions set out in the Privacy Act 1988, you may seek access to and correction of the personal information which we hold about you by contacting our Privacy Officer. We will require you to verify your identity and to specify what information you require. If a fee is charged for providing access, you will be advised of the likely cost in advance.

## **HOW CAN YOU 'OPT OUT'?**

From time to time, we may use your personal information to provide you with marketing communications in relation to special offers, competitions, product and services that we have available. If you would not like to receive these communications from us, you may opt out by contacting our Privacy Officer.

## **ARE WE LIKELY TO DISCLOSE YOUR PERSONAL INFORMATION OVERSEAS?**

We may disclose your personal information to the following recipients:

- To third parties who assist us in providing services or who perform functions on our behalf (such as third-party service providers);
- To anyone where we are required or authorised by law to do so; and
- To anyone else to whom you authorise us to disclose it.

## **APPLICATION OF EUROPEAN PRIVACY LAWS**

If you are an individual in a country in the European Economic Area (EEA), we may be required to comply with the EU General Data Protection Regulation 2016/679 (the GDPR) which applies to us when processing the personal information of individuals (data subjects) who are in countries in the EEA in relation to offering you our products or services, or if we monitor any of your behaviour when in those countries. This privacy policy shall apply in such cases.

We are the data controller for our website and services provided through our website.

## LINKS TO OTHER WEBSITES

We may provide links to other websites operated by third parties. We make no representations or warranties in relation to the privacy practices of any third-party website and we are not responsible for the privacy policies or the content of any third party website. If you visit these websites, they will be governed by their own terms of use (including privacy policies).

## NOTIFIABLE DATA BREACHES SCHEME

In the event of any loss, or unauthorised access or disclosure of your personal information that is likely to result in serious harm to you, we will investigate and notify you and the Australian Information Commissioner as soon as practicable, in accordance with the Privacy Act 1988.

## HOW CAN YOU MAKE A PRIVACY RELATED COMPLAINT?

If you have any questions about privacy-related issues or wish to complain about a breach of the Australian Privacy Principles or the handling of your personal information by us, please contact our Privacy Officer. We may ask you to lodge your complaint in writing. Any complaint will be investigated by the Privacy Officer, and you will be notified of the decision in relation to your complaint as soon as is practicable after it has been made, usually within 30 days.

If we are unable to satisfactorily resolve your concerns about our handling of your personal information, you can contact the Office of the Australian Information Commissioner ([www.oaic.gov.au](http://www.oaic.gov.au)).

## MODIFICATIONS OR UPDATES TO THIS POLICY

This privacy policy will be reviewed from time to time to take account of new laws and technology, changes to our operations and practices and the changing business environment. Please note that if at any time we are required by law to release your personal information, we must cooperate fully. This privacy policy does not apply to our acts or practices that relate to employee records of current or former employees.
